**नियम एवं शर्तें**

(I) Tender E-procurement की website पर जारी BOQ में ही प्रस्तुत किया जाना चाहिए, अन्यथा उस पर विचार नहीं किया जायेगा।

(II) अपंजीकृत फर्मों के द्वारा Tender दिए जाने के समय (Bid Security) रू0 3000\/- (डिमांड ड्राफ्ट, एफ.डी.आर., बैंकर्स चेक एवं बैंक गारंटी के रूप में) अग्रिम जमानत राशि, प्रबंधक, सरकारी अफीम एवं क्षारोद कारखाना, गाजीपुर के नाम जमा करना होगा। अग्रिम जमानत राशि टेण्डर के साथ न होने की स्थिति में, टेण्डर पर विचार नहीं किया जाएगा।

**SPECIAL CONDITIONS OF CONTRACT FOR ENGAGING THE CONTRACTOR LABOUR.**

**Compliance of Various Labour and Industrial Legislations-**

For any work in GOAW, Ghazipur the work contract except the work related to Supplying of goods/articles/substances have been issuing by the Management, wherein Contract labours are being engaged by Contractor for execution of said work order. In order to effectively executive the Work order the Model terms and conditions would submissive in the Tender documents or Work order for better clarity of statutory responsibility between the Management and the Contractor in respect to engagement and deployment of contract labour in the Factory/ Residential Colony .

**Provisions of Workmen's Compensation Act**

1. It is the Contractor liability to pay the compensation to a worker for death or personal injury resulting into total or partial disablement or occupation disease caused to a worker arising out of and during the course of employment (Section 3). The amount of compensation is as per the Section 4 of the Act. If a Contractor deny or fail to pay the Compensation under this act, the same may hold his EMD/Security Deposit/ monthly running bill amount.
2. In case of any injury during the workplace, the contractor shall liable to make necessary arrangement for treatment of their worker and all expenditure is born by the Contractor exclusively.

**Other Condition of Contract-**

A. In case any damage to machinery, building, equipment made by the Contract Worker, the same may recovered from the Running bill of contractor on Report of the Section/building l/c . The Rate of damage shall be asses by the Committee chaired by the Manager, GOAW Ghazipur along with the others members' i.e F.E, W.E and Concern Building l/c.

B. The contractor shall not employ a person below 18 years of age. For the purpose of execution of work/ services under the contract,

**Penalty-** For any Dis-adherence of work order/non satisfactory work performed by the Contractor or non visit of contractor workers, Sweeper, the Management shall deduct the specific amount as prescribed by the GM, GOAW Ghazipur from the running bill of contractor.

**Termination of contract-**

If any contrary to above provision or rule of law, the GOAW, Ghazipur through General Manager shall terminate the contract at any time.

3. Tenders uploaded upto prescribed time and date will be opened on 21.07.2020 at 15.05 Hrs
4. Financial Bid in the prescribed format as per BOQ shall be duly filled in and signed by the authorized signatory and uploaded online by the bidder along with the self-attested and stamped scanned copies of the following documents:-

**Special Instructions for e-submission of bids**

1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
2. More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>

**REGISTRATION**

- a. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:<https://eprocure.gov.in/eprocure/app>) by clicking on the link “**Online bidder Enrolment**” on the CPP Portal which is free of charge.
- b. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- c. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- d. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / n Code / e-Mudhra etc.), with their profile.
- e. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC’s to others which may lead to misuse.
- f. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC /e-Token.

**SEARCHING FOR TENDER DOCUMENTS**

- i. There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- ii. Once the bidders have selected the tenders they are interested in, they may download the required documents/ tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS /e-mail in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

## **PREPARATION OF BIDS**

- a. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- c. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- d. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” or “Other Important Documents” area available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

## **SUBMISSION OF BIDS**

- i. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- ii. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- iii. The server time (which is displayed on the bidders’ dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- iv. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- v. Upon the successful and timely submission of bids (i.e. after Clicking “Freeze Bid Submission” in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
