GENERAL INFORMATION FOR THE TENDERERS

1. With reference to our advertisement published in various newspapers in the month of **March, 2019** sealed tenders are invited for supply of Raw Water as per quantity mentioned in Annexure-A.
2. Last date for receipt of tenders is up to 15:00 hrs. of **25/03/2019**. Tenders received after this date and time shall not be opened / considered. Delay in Postal / Courier transmission will not be entertained.
3. Tenders will be opened at 15:30 hrs. on **25/03/2019** in the Office of the General Manager. Govt. Opium & Alkaloid Works, Station Road, Neemuch-458 441 (M.P.) in presence of such tenderers or his/their authorized representative(s) who wish to be present at the time of opening of the tenders. Authorized representative should carry letter / authority with him otherwise he will not be permitted to participate in tender opening.
4. Tenders not submitted on this tender document shall not be considered.
5. The tenders should be sent in double sealed cover and the covers should be super scribed with tender No., Name of item and date of opening of tender.
6. The % of GST (Goods & Service Tax), if applicable, will clearly be mentioned in the quotation as well as supply invoice (if supply order placed).
7. Rates are to be quoted for items strictly as per specifications and the specified quantity as mentioned in the format given in Annexure/Schedule of rates of that specified item

8. No advance payment/Document through Bank on any account shall be made against the supply. After inspection of the supplied items / stores and on the supply being found satisfactory, the payment should be made at the earliest through PFMS / RTGS.
9. Tenders should as far as possible be free from cuttings, overwriting and errors, however, in unavoidable circumstances, such cutting etc., if any should be neatly scored out and written afresh and attested with dated signature of the tenderer.
10. Tenders should quote the number of their sales Tax Registration, PAN/TAN, Service Tax registration etc., if any in the tender.
11. Earnest Money Deposit of the unsuccessful tenders shall be released after finalization of the tender, as early as possible. No interest on the Earnest Money Deposit / Security deposit shall be paid by us on any score, what-so-ever be. For early release of Earnest Money deposit the firms are requested to enclose pre-receipt of the same.
12. Two set's of terms and conditions are enclosed herewith. As a token of acceptance, the tenderers have to return a set of the terms and conditions alongwith the schedule of rates / quotations, duly accepted, signed and sealed. Tenders received without terms and conditions, not duly sealed and signed will not be considered.
13. The tenderers should also enclose a brief introduction/ particulars, on their letter-head in support of their capability to execute the supply order, which is likely to be verified before finalizing the tender.
14. The General Manager, Government Opium & Alkaloid Works, Neemuch reserves the right to reject or accept any tender without assigning any reason.
15. A self-declaration on stamp paper shall be submitted duly notarized to the effect that the firm is not black listed for Government transaction by any Department / PSU of Government of India.
16. Canvassing for obtaining tender will be disqualified the bidder from tender process.
17. Quotation submitted should have the validity of 90 days from the date of tender opening.
18. The cost of tender documents is Rs 500/- for each item, separate tender should be submitted quoting tender no. in case the form is downloaded from our Web-Site the cost of tender form should be enclosed by separate bank draft prepared in favour of The Drawing & Disbursing Officer, Govt. Opium & Alkaloid Works, Neemuch, Otherwise tender will not be accepted.

TERMS & CONDITIONS

TO BE FURNISHED BY THE TENDERERS DULY SIGNED AND ACCEPTED

The tenderers have to accept the following terms and conditions and enclose a copy of this duly accepted along with their tender:-

01. Tenders not strictly in conformity with the specifications of the items given in the ANNEXURE-`A' shall not be considered.
02. Rates should be quoted on F.O.R. NEEMUCH DESTINATION basis which is located 135 kms. From Ratlam (M.P.) and 56 kms. From Chittorgarh (Rajasthan).
03. Tenders should be accompanied alongwith **Earnest Money Deposit** as mentioned in Schedule of rates.(annexure `A' enclosed herewith) in the form of Demand Draft in favour of `**Drawing & Disbursing Officer, GOVT. OPIUM & ALKALOID WORKS, NEEMUCH, M.P. or deposit in cash with the Cashier of GOAW, Neemcuh.** Tenders not accompanied with the earnest money prescribed shall not be considered. Out station Cheques will not be accepted.
04. All expenses and taxes / levies other than those quoted in the tender shall be borne by the supplier.
05. The rates quoted must remain valid till completion of the supply of the entire quantity. No conditional tenders shall be considered and accepted.
06. In case the tenderer withdraws his tender or in the event of his tender being accepted, fails to execute the supply / purchase order within the stipulated time, the Earnest Money furnished by him shall be liable to be forfeited without any prejudice to other rights of the Government of India under the law.
07. In the event of tender being accepted, the tenderer shall be required to enter into an Annual Rate Contract for the supply of raw water to be placed by the General Manager / Manager, Government Opium & Alkaloid Works, Neemuch. The supply shall be made to this works through tractor tanker of capacity not less than 4,00 ltrs., the capacity of the tanker as assessed by this works shall be final with out any dispute.

08. In case of delay or failure to execute the supply order(s) against annual rate contract by the tenderer, the General Manager, GOAW, Neemuch without prejudice to any other right available under law, shall have the option (i) to purchase from elsewhere at the risk and cost of the supplier the material not delivered, and (ii) to cancel the order without any liability on either side.
09. In case of exigencies, unforeseen circumstances etc., the General Manager, Govt. Opium & Alkaloid Works, Neemuch, MP reserves the right to cancel the supply order for whole or the balance quantity or part of it by way of one month Notice without assigning any reason what-so-ever.
10. The General Manager, Govt. Opium & Alkaloid Works, Neemuch also reserves the right not to accept the lowest or any quotation/ tender or to split up the tenders and place order with one or more tenderer(s) without assigning any reason what-so-ever.
11. Legal proceedings, if any, emanating from Annual Rate Contract / Supply Order shall fall within the jurisdiction of the competent court of Neemuch, District: Neemuch, Madhya Pradesh. In case of dispute the General Manager of this works will be the sole arbitrator, whose decision will be binding on all parties.
12. The stores when received at the Government Opium & Alkaloid Works, Neemuch, MP shall be inspected with respect to quality and quantity
13. No advance payment / Document through Bank on any account shall be made against the supply. After inspection of the supplied items / stores and on the supply being found satisfactory, the payment should be made at the earliest by way of account payee Demand Draft or a Cheque in favour of the supplier.
