No.9827562199 is a co-ordinate. No complaint whatsoever will be entertained after the bid is submitted or before or after the vehicle is lifted from the premises. No request for inspection after submission of bid will be accepted.
3. The sealed bids superscribed 'Bid for sale of condemned vehicle' on an envelope, will be received latest by 15.00 hrs. of 09.08.17 through Indian post/Courier/By Hand will be accepted. The same will be opened on in the presence of bidders, if any at 15.30 hrs. on the same day. No bids either by post/courier or in hand will be received after the time and date specified above. The bids should be addressed to the General Manager, Govt. Opium and Alkaloid Works, Neemuch (MP).
4. The offers given in the valid bids received on due date and time only will be considered.

The bidders are required to submit earnest money deposit Rs.3000/- in the form of DD/FDR/ Cheque drawn in favour of DDO, GOAW, Neemuch along with the bid which shall be returned to the bidders after lifting of vehicle by the successful bidder. In such case the EMD of successful bidder can be adjusted with the bid amount to be deposited.
6. In the event of acceptance of Bids, the successful bidder will be required to deposit full amount (after adjusting the EMD) within indicated period by this office in shape of DD in favour of D.D.O., GOAW, Neemuch.
