# (A) DETAILED INSTRUCTION OF Annual Maintenance (A.M.C) of <u>two sets fired tube oil fired boilers</u> with Cyclone Separator:

## Terms & Conditions:-

- 1. The contract period will be 12 months from the date of signature of contract.
- 2. The boiler and cyclone separator should be attended on daily basis by qualified boiler persons. Tubes of cyclone separator should be cleaned by suitable chemical and carbon particle should be removed time to time as per requirement.
- 3. The service engineer of the firm must be make a visit in a month to maintain the boiler at adequate pressure and proper efficiency and must be submitted their report every month.
- 4. The contract covers repair and maintenance of two oil fires boiler with cyclone separator and their components. A mechanise and installation fitted in the boiler house. During contract required spare worth Rs. 1000/- for single item in a month shall be provided by the firm under AMC.
- 5. All mounting of the boilers should be checked in every month and report should be submitted by the service engineer report should be submitted to the works engg.
- 6. All tubes/mounting /Valves etc. of both boilers must be cleaned/calibrated in every three month.
- 7. Descaling / cleaning of all tubes must be carried out in every three months or per directed by W.E .Dsealing material should be provided by the factory.
- 8. Any items/ parts like boiler tube, furnace chambers etc. falling under the preview of Indian boiler regulation act, 1950 will be attended by the firm as per rule
- 9. Any specific break down must be rectified by the firm within 24 hours from the telephonic/ written information by the customer. If it is not rectified within 24 hours a penalty of @ Rs. 2000/-(Rupees Two Thousand only) per day will be imposed on the firm and it will be deducted from contractor's bill.For this, a complain register to be maintained at boiler house and all entries should be signed by the firms representative.
- 10. A set of tools and tackles shall be provided for day to day working by contractor and he shall arrange any special tools required for repairing work.
- 11. Required items like Kerosene. Cotton waste, grease, lubricants etc. shall be provided by GOAW, Ghazipur.
- 12. The firm has responsible to get ready the Boilers for inspection by the competent authority of Directorate of boiler, Kanpur. Firm has also responsible for any shortcoming during the inspection and also responsible to obtain inspection certificate from boiler directorate Kanpur with his own efforts.
- 13. Under the contract firm has to rectify the all defects of all parts of the two oil fired boilers, its mounting, related all pumps, fitting, repairing/ rewinding of the motor, panel board, all related installation items service and storage tank with all motors and pumps and fitting which are installed in boiler house and its premises. All works should be done as per direction of Works Engineer.

14. If any lacks of above, the firm has responsible for it and General Manager has empowered to impose the penalty and his decision will be final in this regard.

15. The firm must have an experience of at least 2 years of repair and maintenance as well as ooperation of 2.5 TPH or higher capacity boiler in any Industrial production house is eligible to quote the rate. Experience Certificate must be produced with the tender documents, without certificate rate will not be considered.

16. The firm has to be provided one suitable technical person for maintenance of boiler having I.T.I certificate in fitter trade (trained in boiler) / boiler attendant certificate holder on daily basis.

17. The firm will also have to provide one separate boiler attendant during the entire contract periods who is boiler attendant certificate holder issued by the boiler directorate.

18. Attendant Certificate must to provide with the tender document, without certificate tender will not be accepted.

19. The boiler attendant will work in the full month (31 days) or in all working days of factory. He will operate the boiler in one shift daily. The attendant will be responsible for operation of their shift.

20. The duty of the attendant will be decided by the works engineer.

21. If there is any problems/mishapppening arises during the duty of the attendant, then the firm will be fully responsible for it and whatever penalty/ punishment the management decides for that problems/ mishappening. The firm will have to accept it.

22. Other works related to boiler should done by the firms as per direction of W.E.

Note: - When the tenderer presenting their rates, suppliers must ensure that the entire System is well understood and presents their rate accordingly. No unnecessary paperwork will be accepted after the issuance of the work order.

#### **Special Instructions fore-submission of bids**

- 1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
  - a. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
  - b. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
  - c. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / n Code / e-Mudhra etc.), with their profile.
  - d. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
  - e. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC /e-Token.

#### SEARCHING FOR TENDER DOCUMENTS

- i. There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- ii. Once the bidders have selected the tenders they are interested in, they may download the required documents/ tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS /e-mail in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### PREPARATION OF BIDS

- a. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the

number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- c. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- d. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### SUBMISSION OF BIDS

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time

   on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- ii. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- iii. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.

- v.
