<u>Invitation of offer for Empanelment of Chartered Accountant firms as Statutory Auditor of a Company</u>

Chief Controller of Factories, Government Opium and Alkaloid Factories (The Authority) is an Indian government-owned organization with its office located at New Delhi. Government Opium & Alkaloid Factories (GOAF) are government-run manufacturing facilities under the Department of Revenue, Ministry of Finance for processing of raw opium and producing high-quality pharmaceutical alkaloids used in life-saving medicines for palliative care. A concession was awarded to a company for "Setup of production unit for production of Concentrated Poppy Straw (CPS) from Opium Poppy Crop and extractions of semi refined morphine on PPP basis" at Neemuch, Madhya Pradesh.

- 2. Applications are invited from reputed firms of Chartered Accountants having their registered offices in India for **'Empanelment as Statutory Auditor of the Concessionaire Company for audit of its books of accounts'** as per following eligibility criteria:
- (a) The CA firm should have conducted statutory audit of the annual accounts of at least one hundred companies registered under the Companies Act, 1956, including any reenactment or amendment thereof, of which at least ten should have been public sector undertakings;
- (b) The CA firm should have at least 05 (five) practicing Chartered Accountants on its rolls, each with a minimum experience of ten years in the profession;
- (c) The CA firm or any of its partners should not have been disqualified or black-listed by the Comptroller and Auditor General of India or the Authority; and
- (d) The CA firm should have an office in the State of Madhya Pradesh or Rajasthan or Uttar Pradesh or Maharashtra or Gujarat or Chhattisgarh with at least 02 (two) practicing Chartered Accountants on its rolls in these States.
- 2. Interested CA firms meeting the eligibility criteria should submit a statement of their capability including the bio-data of all the practicing Chartered Accountants on its rolls. In particular, each firm shall be required to furnish year-wise information relating to the names of all the companies with an annual turnover exceeding 25,00,00,000 INR (rupees twenty-five crore only) whose annual accounts were audited by such firm in any of the preceding 05 (five) Accounting Years.
- 3. Before applying, CA firms should ensure that they fulfil all the eligibility criteria mentioned

in the invitation of offer document. Eligible CA firm have to apply in prescribed format through post and email only.
