Initially Shri N.M. Rudresh, In-charge Purchase, GOAW, Neemuch welcomed Manager, Shri Rahul Raising, all the officials & representatives of all participating firms. Shri N.M. Rudresh, In-charge Purchase, GOAW, Neemuch briefed regarding the tender of Supply, Installation, Testing and commissioning of Electrical Panels and related works at GOAW, Neemuch He also emphasised on the time constraint and importance for this tender. Thereafter the following discussions were made: -

i) Shri M.K. Kishore, CE/ WE of GAOW, Neemuch introduced himself to all the participants & explained about the work of Supply, Installation, Testing and commissioning of Electrical Panels and related works at GOAW, Neemuch. He also enlightened the eligibility criteria for participation in the tender and other terms & condition of the tender.

- ii) Shri M.K. Kishore, CE/ WE, GOAW, Neemuch then asked the participants to discuss their query/ clarification regarding the tender.
- The representative of Standard Group, Hydrabad, Shri Balu Subarnayam enquired about the MCC Panel. It was clarified that all the specification of the MCC panel are mentioned in the tender document. It was also clarified that the Cable, Push Button, Glands will be provided by the GOAW, Neemuch.
- *iv)* Further, it was clarified that hardware material of the duct will be provided by the GOAW, Neemuch.
- v) The representative of *Pirotech Electronics*, *Udaipur*, *Shri Neetish* enquired about the supply of the material. It was clarified that all the details are mentioned in the Annexure-A of the tender document. GOAW, Neemuch will provide the PVC Cables, Cable Glands, Push Button, hardware material of the Duct. Rest of all the required material will be in the scope of the contractor as mentioned in Annexure-A.
- vi) The representative of Standard Group, Hydrabad, Shri Balu Subarnayam enquired about time limit of the completion of the work. It was clarified that the time limit will be the Sixty days from the date of issuance of the work order.
