## Minutes of the Meeting held on 02.02.2023 on compassionate appointment

				affidavit submitted earlier she has also mentioned that house was given on mortgage. Therefore, committee is of the view that, even there is no material evidence for house rent received, as she has received the money in lieu of house, the interest rate earned if any will be considered as income from property. Hence committee decides to calculate the notional interest @6% (as on FD) on mortgage money (Rs. 601000/-) received as income i.e. around Rs. 36000/- for a year and deduct the relevant points for it by 2. Thus she gets 08 points in place of earlier 10 points but remains on the same position by getting total 73 points. Therefore the committee
				recommends her for the post of MULTI TASKING STAFF only as per relaxation given in Para 2 of O.M. No. 14014/2/2009- Estt.(D) Dated 03.04.2012.
2.	Arjun Bairagi, Son, 07.03.1988 (10 <sup>th</sup> passed)	Dhanna Lal Bairagi, MTS, 02.03.1999	58	As per verification report it is found that the applicant had submitted correct information. The post of MTS(Technical) has various sub-posts under it like Semi-Skilled Worker, Weighman, Carpenter, Worker, Dresser, Ward Boy. The qualification required as per Recruitment Rules for the post of Ward Boy is matriculation and the candidate possesses the required qualification. Therefore, Committee recommends him for appointment on post of "Ward Boy" on compassionate grounds, for which he possesses the required qualification.

Therefore, the Committee recommends to reject the application of the applicant and close the case for future appointments on compassionate
				grounds.

Further for the post of Technician Grade-I, the candidates having required qualification are placed at Sr. No. 14 & Sr. No. 19 having merit points 49 and 41 respectively. Therefore committee is of the view that as candidates have merit points less than 50, they shall not be considered for appointment on compassionate grounds. The committee recommends to keep the post of Technician Grade-I vacant for future cycle of compassionate appointment. The recommendations of committee of above applicants stand amended with respect to committee's recommendations dated 28.10.2022.
