## Annexure "A"

### **1. Scope of Work :**

- a) Supply; Installation and commissioning of the new two top sections and hood.
- b) Removal of top two sections of the chimney<sup>AND</sup>'s hood.

#### **Material :**

- **Structural steel :** Steel plates and sections to be used in the construction of chimney segments i.e. top piece and second top piece along with chimney hood shall conform to IS – 226 – 1969; IS – 961 – 1962 or IS – 2062 – 1969 whichever is appropriate.
- **Electrodes for welding :** Covered electrodes shall conform to IS – 814 – 1970 or latest amendment.
- **Steel for Bolts and Nuts :** (Hot dip galvanized zinc) :- All bolts and nuts shall conform to IS – 1367 – 1967 or latest amendment.
- **Washers (Hot dip galvanized Zinc) :** - Plain washers shall be made of steel conforming to IS – 226 – 1969 – IS – 2062 – 1969 or St 42 – 0 of IS 1977 – 1969.
- **Guy ropes and fittings (if required) :** Guy ropes shall conform to IS : 2141 - 1958 and IS : 2266 – 1963 and latest amendment and shall be galvanized or protected from corrosion by other suitable means.

#### **General :**

- **Joining flange :** A steel flat/ flange or angle fitted to each end of chimney section to enable sections to be connected together.
- **Guy or stay (if required) :** Arrangement for supporting the chimney shaft.
- **Gusset :** Usually triangular or trapezoidal fins of steel fixed to the shell as well back up rings of the shell at the flange joints.

#### **Steel Chimney Sections :**

OD : 650 mm

THK : 06 mm

Length of each section : 5000 mm or 5 mtrs with flange joint. The tentative sketch along with the dimensions are enclosed as encl. 1 to 5.

#### **Steel chimney Hood :**

The tentative sketch along with the dimensions are enclosed as encl. 1, 4, 5.

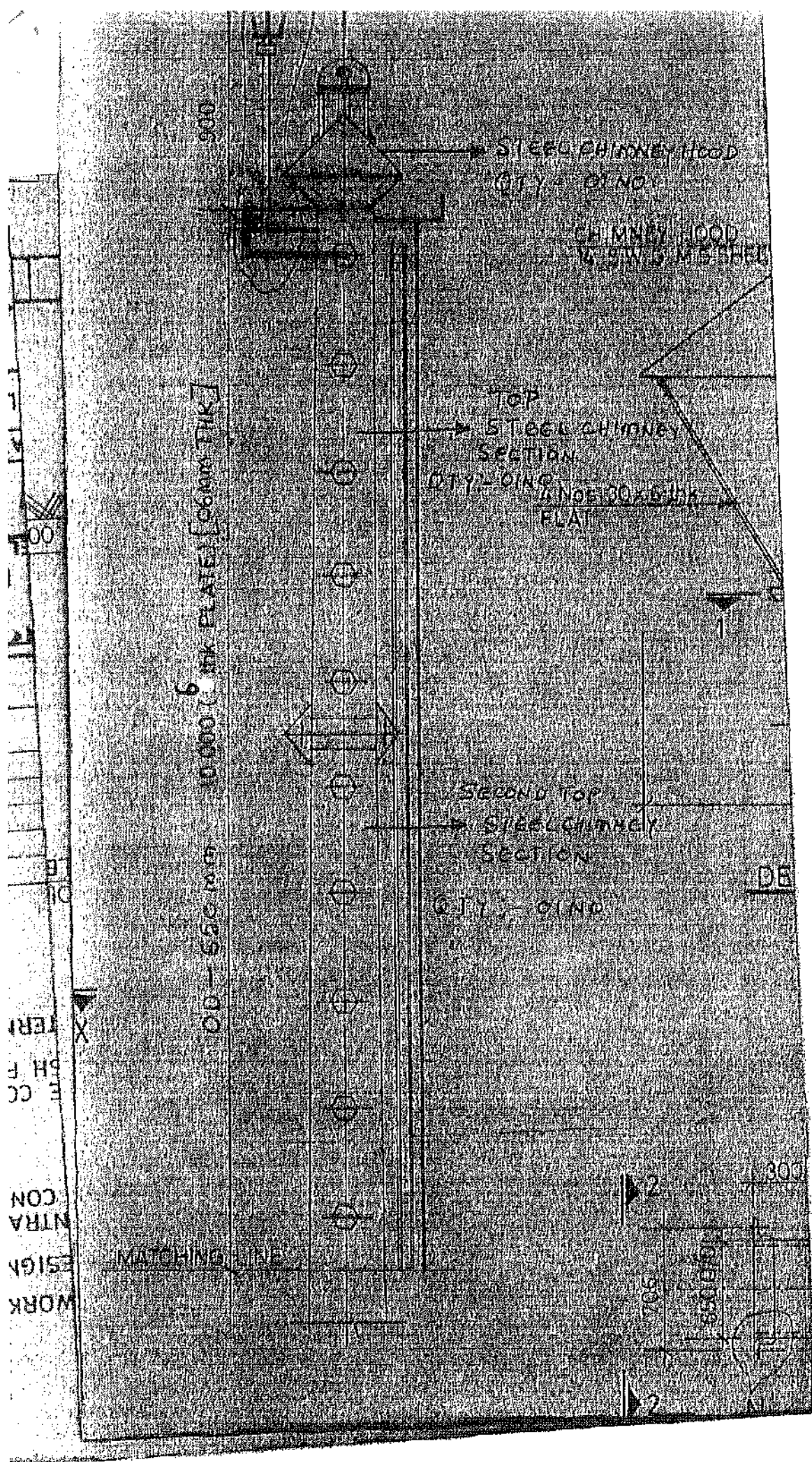
Other Informations :

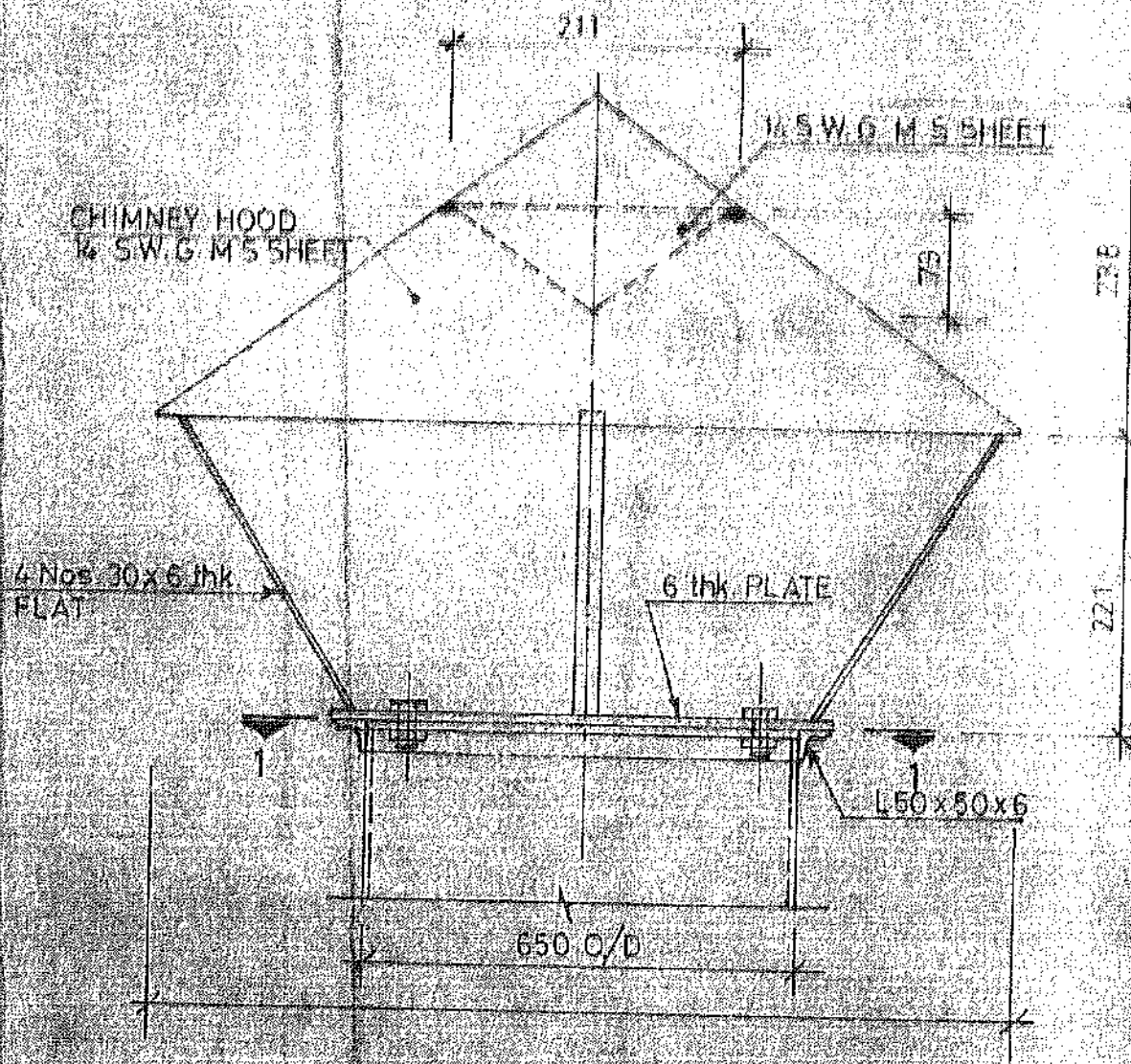

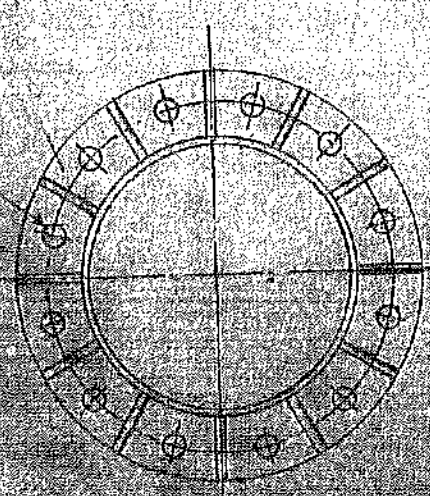

4. Financial Bid in the prescribed format as per BOQ shall be duly filled in and signed by the authorised signatory and uploaded online by the bidder along with the self-attested and stamped scanned copies of the following documents: -

  7. Material test certificate (Physical & Chemical to confirm the grade of material used) shall be made available at the time of commissioning and to be submitted along with the material supply.
  8. installation: Removal of the existing CHIMNEY from the Plant, shifting it to workshop/scrape yard of this works and installation of new CHIMNEY at respective place
  9. The welding machine, mechanical cutting machine, drilling machine (gas cutting machine is not available) etc. can be made available from this works. All consumable for welding drilling cutting and all type of fasteners and fitting shall be in the scope of contractor only.

6. If it is noticed that the goods supplied do not conform to the specification of the order, GOAW, Neemuch shall have the right to reject the materials in part or full. The supplier shall be liable to replace the rejected materials within the stipulated time. Till the replacement is done, the rejected materials shall be lying at the risk, cost and responsibility of the supplier.
  7. Earnest Money of the unsuccessful tenderes shall be released after finalization of the tender, as per General Financial Rules 2017. Interest on the Earnest Money Deposit / Security Deposit will not be paid on any score, what-so-ever.
  8. A Self declaration on stamp paper shall be submitted duly notarized to the effect that the firm is not BLACK LISTED for Government transaction by any Department / PSU of Government of India.

## TERMS AND CONDITIONS

1. Tenders not strictly in conformity with the specifications of the work given in the tender form shall not be considered.
2. Rates should be quoted on F.O.R. Neemuch basis (inclusive of all taxes/levies applicable). Neemuch is located 135 kms from Ratlam (MP) and 55Kms from Chittorgarh (Rajasthan).
3. The welding machine ,mechanics cutting machine ,drilling machine etc. (Gas cutting Machine is not available) can be made available from this works. All consumables for welding, drilling, cutting and all types of Fosters and fitting shall be in the scope of contractor only.
4. The bid security/EMD as mentioned in annexure-D in the form of A/c payee demand draft, fixed deposit receipt, Bankers cheque or Bank guarantee from any of the commercial Banks drawn in favour of Assistant Chief Accounts Officer, Govt. Opium and Alkaloid Works, Neemuch (except Micro and small enterprises (MSEs) as defined in MSE procurement policy issued by department of Micro, Small and Medium Enterprises (MSME) or registered with the Central Purchase Organisation or the concerned Ministry or department)/NSIC must be accompanied along with duly signed terms and conditions and self declaration.
5. In case of delay or failure to execute the Supply Order (s) against the contract, the General Manager, Govt. Opium & Alkaloid Works, Neemuch without prejudice to any other right, under laws, shall have the option :
  - a) To recover liquidated damage (LD) of the value of stores which is not delivered or delayed shall be recovered as follows :

In case of the delivery of stores or any installment thereof is accepted after expiry of the original delivery period, the GM may recover from the supplier the LD equivalent to 0.5(Half) percent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The maximum LD shall not exceed 10(Ten) percent of the value of delayed goods.
  - b) To purchase from other sources at the risk and cost of the supplier to extent of material not delivered.
  - c) To cancel the Supply Order without any liability on G.O.A.W.
  - d) To blacklist and debar the company from making any future supplies to any Govt. Department / PSU of Govt. of India.
6. In case of exigencies, unforeseen circumstances the General Manager reserves the right to cancel the work order for whole work or part of it by way of one month notice without assigning any reason.
7. Legal proceedings, if any, emanating from this contract shall fall within the jurisdiction of the competent court of Neemuch, District Neemuch, State Madhya Pradesh.

8. The tenderer shall submit a copy of partnership deed in case of partnership firm or certificate of proprietorship in case of proprietary firm in case of partnership firm the name of the person who is authorised to sign the documents & agreement etc. shall be submitted by the tenderer on required stamp papers.
9. In case, the tenderer withdraws his offer or in the event of tenderer failing to execute, after his tender is accepted, the Earnest Money Deposit furnished by him shall be forfeited without any prejudice to other rights of Govt. of India under any law.

**Special Instructions for e-submission of bids**

1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
2. More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>

**REGISTRATION**

- a. Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app> ) by clicking on the link “**Online bidder Enrolment**” on the CPP Portal which is free of charge.
- b. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- c. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- d. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- e. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- f. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

**SEARCHING FOR TENDER DOCUMENTS**

- i. There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. - ii. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

**PREPARATION OF BIDS**

- a. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- c. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the



tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

- d. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### **SUBMISSION OF BIDS**
