Brief description of duties: The Works Engineer will be responsible for work under the direct supervision and control of the General Manager. He will be in charge of all the engineering function of the undertaking. His main duties constitute supply of essential services like water & power to the Alkaloid Plant and Opium Factory. He will be responsible for proper maintenance and repair of all plant and machinery of the undertaking. All repairs and original works (Civil/ Mechanical/Electrical) of the undertaking will be carried out under his guidance and supervision.
