The prospective bidder can bid for the minimum quantity of 500 kg. In case any bidder offers their bid for less than full quantity of 6500 Kgs, the EMD shall be calculated on pro-rata basis supposing that EMD of Rs. 39,00,000/- is for offered quantity of 6500 Kgs. Suppose any bidder offers their bid for a quantity of 1300 Kgs, the EMD shall be calculated as under:-

# **SECTION - II**

# **GENERAL INSTRUCTIONS TO INTERESTED FIRMS/PARTIES (GIT)**

#### Introduction

The Chief Controller, Govt. Opium & Alkaloid Factories, New Delhi for and on behalf of the President of India invites E-AUCTION from eligible and qualified Interested firms/parties for bidding to purchase a quantity of 6500 Kgs of Noscapine BP (or a minimum quantity of 500 Kgs) stored at GOAW, Neemuch and/or GOAW, Ghazipur.

Failure to provide the required information and/or failure to comply with the instructions in these E-AUCTION documents or give false/incorrect information may result in rejection of its E-AUCTION.

#### **Definitions**

The following terms used in these documents shall have the meaning as indicated below:

#### Definitions:

- i. "Bidder" means Interested firms/parties who has submitted valid bid in this E-AUCTION.
- ii. "Contract" means the written agreement entered into between the Seller and the Bidder together with all the documents mentioned therein and including all attachments, annexures, etc.
- iii. "Earnest Money Deposit" (EMD) means monetary guarantee to be furnished by a Prospective Purchasers /bidders .
- iv. "H1" means the Interested firms/parties whose E-AUCTION is the highest one.
- v. "Seller" means the President of India acting through authorized officers and Chief Controller, Govt. Opium & Alkaloid Factories, New Delhi, Dept. of Revenue, Ministry of Finance, Govt. of India, Near NSIC-Technical Centre, Block-J, Phase-III, Okhla Industrial Estate, New Delhi -110 020 and includes his successors in office, nominees, authorized representatives.
- vi. "Successful Bidder/Purchaser" means the individual, company or the firm purchasing the goods, to which the award has been issued under this E-AUCTION.
- vii. "E-AUCTION/E-AUCTION bids" means quotation/bid submitted online.
- viii. "Prospective Purchasers /bidders" means individual, company, firm offering the E-AUCTION bids.

# Language of E-AUCTION

The E-AUCTION and all subsequent correspondence shall be in English.

#### **Eligible Interested firms/parties**

Only Interested firms/parties who are registered Indian firms, having valid Drug manufacturer license from the concerned Competent authority for using Noscapine B.P., are eligible to apply.

To be eligible, the Prospective Purchasers /bidders should have not been banned or suspended from Government transactions due to any reason including corrupt and fraudulent practices.

#### **E-AUCTION Expense**

The Interested firms/parties shall bear all costs and expenditure incurred and/or to be incurred by it in connection with its E-AUCTION including preparation, mailing and submission of its E-AUCTION bids and for subsequent processing the same. The Seller will, in no case be responsible or liable for any such cost, expenditure etc. regardless of the conduct or outcome of the E-auctioning process.

# **Amendments to E-AUCTION Enquiry Documents**

Seller may, at any time prior to the deadline for submission of E-AUCTION, for any reason, whether at his own initiative or in response to a clarification requested by a potential Prospective Purchasers /bidders , modify the E-AUCTION Documents by issuance of Addenda or Corrigenda. They can be downloaded from the websitewww.goaf.gov.in or www.eprocure.gov.in.

All such amendments shall be binding on the Prospective Purchasers /bidders. The E-AUCTION Documents shall be deemed to be amended only by way of the amendments mentioned above. Any other communication issued to the interested firms/parties shall not be construed as an amendment to the E-AUCTION Documents.

In order to give the potential Interested firms/parties reasonable time to prepare their E-AUCTION as per the amendment, the Seller may, at its discretion extend the deadline for the submission of E-AUCTION and other allied time frames, which are linked with that deadline.

#### Clarifications on E-auction Documents/ Pre-Bid Meeting

Prospective Purchasers /bidders seeking clarifications on the e-auction document should submit their queries *online or through e-mail* (*goaf.ccf@cbn.nic.in*) by 16.04.2023 upto 1500 hrs. These queries would be answered in the pre-bid conference.

A Pre-Bid conference will be held on 17.04.2020 at 1430 hrs. in the Conference Hall, O/o Chief Controller, Near NSIC-Technical Centre, Block-J, Phase-III, Okhla Industrial Estate, New Delhi -110020. Prospective Purchasers /bidders or their authorized representative(s) may attend the Pre-bid conference. The authorized representative(s) who attend the Pre-Bid Conference should bring with them letters of authority from the Prospective Purchasers /bidders they represent.

All clarifications provided at or in connection with the pre-bid conference shall be uploaded on the departmental website <a href="www.goaf.gov.in">www.goaf.gov.in</a> or <a href="www.goaf.gov.in">www.eprocure.gov.in</a> and these shall become part of the e-auction document. No queries and requests for clarifications will be entertained after the Pre-Bid Conference.

## **Documents Comprising the E-auction**

The E-auction shall be submitted online in single cover containing Price Bid.

Price Bid shall, inter alia, contain the following:

- a) Scanned copy of Earnest money
- b) Documentary evidence of Drug manufacturer license from the concerned Competent authority for using Noscapine B.P., PAN & GST details.
- c) Certified annual reports for the last three years showing the turnover and financial results of the Prospective Purchasers /bidders;
- d) An undertaking to the effect that the Prospective Purchasers /bidders have not been banned or suspended from Government transactions due to any reason including corrupt and fraudulent practices.

# <u>It shall be ensured that Auction/Price bid is only submitted</u> online.

A Prospective Purchasers /bidders, which does not fulfill any of the above requirements and/or gives evasive information / reply against any such requirement, shall be liable to be ignored and rejected.

# **E-auction currencies**

Price must be quoted in Indian rupees only.

# **Contract Price**

The Contract Price of the material shall be the price of total quantity of material purchased by bidder from GOAW, Neemuch or GOAW, Ghazipur. This price shall be firm and fixed and not subject to any variation except in cases where the rate of applicable taxes payable in India or at the place of delivery undergoes a change. These taxes shall be paid as per actual.

If seller is required by Indian Law to deduct or withhold any other taxes or other amounts, the gross amount payable by Seller shall be paid after making such deductions or other withholdings. Necessary certificate for the deductions so made will be issued by the Seller.

#### **Duties and Taxes**

The Prospective Purchasers /bidders shall pay all Indian taxes, duties, and levies, lawfully assessed in pursuance of the contract.

#### Security Deposit (SD)

Successful tenderers/ purchasers, shall have to submit a Security Deposit (SD) @ 25 (twenty-five) per cent of the total sale value of the contract within seven calendar days of the issue of the acceptance letter/sale order (excluding the date of issue). The SD shall be deposited in the form of online payment/bank draft/pay order, drawn on any of the commercial bank in favour of officer concerned as mentioned in the NIT. If the bidder does not lift the contracted quantity within the stipulated time as per contract, the Seller shall initiate necessary action for forfeiting the amount of Security Deposit and EMD.

# **Terms and Mode of Payment**

The detailed terms and mode of payment shall be asunder:

The Performa/commercial invoice will be provided to the successful bidder w.r.t. the quantity bided for, for making the payment to the Opium factories for the bidding quantity at successful price. All the payments shall be done using online mode as per Govt. regulations.

# **Earnest Money Deposit(EMD)**

The earnest money is required to protect the Seller against the Prospective buyer's withdrawing or altering its bid during the validity period. Hence EMD amount must accompany with the e-auction documents. EMD is required to be submitted at Office of the CCF, New Delhi by 04.05.2023 at 1300 hrs. Scanned copy of EMD is required to be uploaded along with auction bid. Prospective Purchasers /bidders /bidders, who are currently registered and also will continue to remain registered during the e-auction validity period with Directorate General of Supplies and Disposal or with National Small Industries Corporation (NSIC), New Delhi are exempted from payment of Earnest money. In case the Prospective Purchasers /bidders falls in these categories for the e-auctioned goods, they should furnish certified copy of their registration with these agencies, clearly specifying the details of items for which they are registered.

The earnest money shall be furnished in the **form of Bank Guarantee** as per format given in Form-3 of Section V of this document.

The earnest money shall be valid for a period of 45 days beyond the validity period of thee-auction.

Unsuccessful Prospective Purchasers /bidders 's earnest money will be returned, without any interest, to them not later than 45 days after the expiry of the e-auction validity period. Successful Prospective Purchasers /bidders 's earnest money will be returned without any interest, after receipt of performance security from that Prospective Purchasers /bidders.

The exact bid security amount should be indicated in the bidding document. The EMD shall be forfeited if the tenderer unilaterally withdraws, amends, impairs or derogates from his offer in any respect within the period of validity of his offer.

# **E-auction Bid Validity**

The e-auction bids shall remain valid for acceptance for a period of 180 days (one hundred eighty days) from the date of e-auction opening prescribed in the e-auction document. Any e-auction bid valid for a shorter period shall be treated as non-responsive and rejected.

In exceptional cases, the Prospective Purchasers /bidders may be requested by the Seller to extend the validity of their e-auction bids up to a specified period. Such request(s) and responses thereto shall be conveyed by e-mail or fax followed by signed hard copy delivered by hand/post/courier. The Prospective Purchasers /bidders , who agree to extend the e-auction validity, are to extend the same without any change or modification of their original e-auction and they are also to extend the validity period of the EMD accordingly.

In case the day up to which the e-auctions are to remain valid falls on/subsequently declared a holiday or

closed day for the Seller, the e-auction validity shall automatically be extended up to the next working day.

# **Inspection of Material at Opium Factories**

- (i) Total 2300 kgs of Noscapine B.P. at Govt. Opium & Alkaloid Works (GOAW), Ghazipur and 4200 Kgs of Noscapine B.P. at GOAW, Neemuch is available to be purchased through e-auction.
- (ii) Inspection of the material (Noscapine B.P.) and packing material at GOAWs may be done by interested firms/bidders between 12.04.2023 to 14.04.2023 during office hours with prior information to the seller.
- (iii) Certificate of Analysis (CoA) of the material to be issued by GOAWs, which will be final and acceptable to all the concerned bidders.

#### Instructions one-auctioning

E-auction documents may be downloaded from Central Public Procurement Portal (CPPP)website: https://www.eprocure.gov.in.

E-auction Bids shall be quoted on per Kg basis and shall be submitted online only at CPPP website: https://eprocure.gov.in/eprocure/app.

Prospective Purchasers /bidders are advised to follow the instructions provided in the "Instructions to the Prospective Purchasers /bidders /Contractors for the e-submission of the bids online through the Central Public Procurement Portal for procurement at https://eprocure.gov.in/eprocure/app".

The server time (which is displayed on the Prospective Purchasers /bidders . dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the Prospective Purchasers /bidders , opening of bids etc. The Prospective Purchasers /bidders should follow this time during bid submission.

Any queries relating to the e-auction documents and the terms and conditions contained therein should be addressed to the E-auction Inviting Authority or the relevant contact person indicated in thee-auction documents.

# Alteration and Withdrawal of E-auction

The Prospective Purchasers /bidders , after submitting its e-auction bid documents, is permitted to alter / modify its e-auction so long as such alterations / modifications are done within the deadline for online submission of e-auctions. Any alteration/ modification in the e-auction bid documents thereafter is not permitted.

No e-auction bids can be withdrawn after the deadline for online submission of e-auction bids and before expiry of the e-auction bid validity period. If a Prospective Purchasers /bidders withdraws the e-auction bids during this period, it will result in forfeiture of the earnest money furnished by the Prospective Purchasers /bidders in its e-auction.

# **Opening of E-AUCTIONs**

The Seller will open on-line the E-AUCTION bids at 1500 hours on 05.05 .2023. In case the specified date of e-auction bids opening falls on / is subsequently declared a holiday or closed day for the Seller, the e-auctions bids will be opened at the appointed time and place on the next working day.

Physical presence of the bidder at the time of opening of e-auction will not be essential in the e-auctioning process. At the appointed time, the bid openers would open the bids online and the details of bids offered by the bidders would be known to all on the CPP Portal.

These bids will be scrutinized and evaluated with reference to parameters prescribed in the e-auction document.

# **Basic Principle**

This office has fixed a Reserve Price per Kg and only those bids whose quoted value per Kg will be equal to or higher than the reserve Price per Kg shall be considered as responsive bids. The bids shall be quoted on per Kg basis excluding taxes. The bid of the highest acceptable responsive bidder may be accepted. However, if the price offered by that bidder is not acceptable, negotiation may be held only with that bidder. In case such negotiation does not provide the desired result, the reasonable or acceptable price may be counter offered to the next highest responsive bidder(s).

The Seller reserves the right to have the financial and other data / credentials claimed by the Prospective Purchasers /bidders verified independently, if necessary by a third party. If the data/ credentials furnished are found to be incorrect, the Seller will reject the particular E-auction summarily. The Seller also reserves the right to reject any E-auction bids submitted by a party if it comes to know *suo moto* of any adverse reports on the financial condition or credentials of the Prospective Purchasers /bidders.

# **Preliminary Scrutiny of E-auction bids**

The e-auctions will first be scrutinized to determine whether they are complete and meet the essential and important requirements, criteria, conditions, etc. as prescribed in the e-auction document. The e-auctions, which do not meet the basic requirements, are liable to be treated as non-responsive and ignored.

# Minor Infirmity / Irregularity /Non-Conformity

If during the preliminary examination, the Seller finds any minor infirmity and/or irregularity and/or non-conformity in a e-auction, the Seller may waive the same provided it does not constitute any material deviation and has no financial impact and, also, does not prejudice or affect the ranking order of the Prospective Purchasers /bidders. Wherever necessary, the Seller will convey its observation on such 'minor' issues to the Prospective Purchasers /bidders either online or by registered/speed post etc. asking the Prospective Purchasers /bidders to respond by a specified date. If the Prospective Purchasers /bidders does not reply by the specified date or gives evasive reply without clarifying the point at issue in clear terms, that e-auction will be liable to be ignored.

#### **Contacting the Seller**

From the time of submission of e-auction to the time of awarding the contract, if a Prospective Purchasers /bidders needs to contact the Seller for any reason relating to this e-auction and / or its e-auction, it should do so only in writing.

In case a Prospective Purchasers /bidders attempts to influence the Seller in his/her decision on scrutiny, comparison & evaluation of e-auctions and awarding the contract, the e-auction of the Prospective Purchasers /bidders shall be liable for rejection in addition to appropriate administrative actions being taken against that Prospective Purchasers /bidders , as deemed fit by the Seller.

#### Seller's Right to accept any E-auction bids and to reject any or All E-auction bids

The Seller reserves the right to accept in part or in full any e-auction or reject any e-auction bid without assigning any reason or to cancel the e-auctioning process and reject all e-auction bids at any time prior to award of contract, without incurring any liability, whatsoever to the affected Prospective Purchasers /bidders or Prospective Purchasers /bidders .

The Seller reserves the right to disqualify any one or more Prospective Purchasers /bidders on the grounds of national security and public interest.

#### **Notification of Award**

Before expiry of the e-auction bids validity period, the Seller will notify the successful Prospective Purchasers /bidders (s) online as well as in writing, by registered / speed post or by fax/ e-mail.

#### **Issue of Contract**

After notification of award, the Seller will mail the contract form (Form-4 of Section - V) to the successful Prospective Purchasers / bidders by registered / speed post for signing.

Within <u>twenty one</u> days from the date of the award, the successful Prospective Purchasers /bidders and Seller shall sign contract as per the mutually convenient date.

Until the contract is signed, the notification of award shall constitute the conclusion of the contract.

#### Non-Receipt of Contract by the Seller

If the successful Prospective Purchasers /bidders fails to sign the contract, his EMD will be forfeited and further actions as deemed necessary by the Seller will be taken against him.

### **Publication of E-auction Result**

The name and address of the successful Prospective Purchasers /bidders (s) receiving the contract(s) will be displayed on the notice board of the Office of the CCF, New Delhi and also on the web site of the Seller<u>www.goaf.gov.in</u> or <u>www.eprocure.gov.in</u>.

# Process to be confidential

Information relating to the examination, clarification, evaluation and comparison of E-auctions and recommendations concerning the award of Contract shall not be disclosed to Bidders or to any other person(s).

# **SECTION - III**

# **GENERAL CONDITIONS OF CONTRACT (GCC)**

#### Insurance

The Bidder shall, in his own interest, insure the goods against loss or damage incidental to transportation. Goods/material will be available for lifting at GOAW, Neemuch or GOAW, Ghazipur.

# **Assignment**

The Bidder shall not assign to anyone, either in whole or in part, its contractual duties, responsibilities and obligations to perform the contract, except with the Seller's prior written permission.

#### **Modification of contract**

If necessary, the Seller may, by a written order given to the Bidder at any time during the currency of the contract, amend the contract by making alterations and modifications within the general scope of contract.

If the Bidder doesn't agree to the adjustment made by the Seller, the Bidder shall convey its views to the Seller within twenty one days from the date of the Bidder's receipt of the Seller's amendment / modification of the contract.

#### **Termination for default**

The Seller may, without prejudice to any other contractual rights and remedies available to it (the Seller), by written notice of default sent to the Bidder, terminate the contract in whole or in part, if the Bidder fails to deliver any or all of the goods or fails to perform any other contractual obligation(s) within the time period specified in the contract, or within any extension thereof granted by the Seller.

### **Termination for insolvency**

If the Bidder becomes bankrupt or otherwise insolvent, the Seller reserves the right to terminate the contract at any time, by serving written notice to the Bidder without any compensation, whatsoever, to the Bidder, subject to further condition that such termination will not prejudice or affect the rights and remedies which have accrued and / or will accrue thereafter to the Seller.

# **Governing language**

The contract as well as all correspondence and other documents pertaining to the contract, which the parties exchange, shall be in English.

# **Notices**

Notice, if any, relating to the contract given by one party to the other, shall be sent by e-mail or fax and confirmed through a signed hard copy delivered by hand/post/courier. The sender shall retain proof of receipt of the notice by the receiver. The addresses of the parties for exchanging such notices will be the addresses as incorporated in the contract.

Any and all notices and communications in connection with this Contract shall be in English and shall be addressed as follows, unless and until otherwise advised to the Seller at:

The effective date of a notice shall be either the date when delivered to the recipient or the effective date specifically mentioned in the notice, whichever is later.

# **Resolution of disputes**

In the event of any dispute or difference between the parties hereto, such disputes or differences shall be resolved amicably by mutual consultation. If such resolution is not possible, then the unresolved dispute or difference shall be referred to arbitration of the sole arbitrator to be appointed by the Secretary, Department of Revenue, on the recommendation of the Secretary, Department of Legal Affairs ("Law Secretary"), Government of India. The provisions of Arbitration and Conciliation Act, 1996 (No.26 of 1996) shall be applicable to the arbitration. The venue of such arbitration shall be at New Delhi or any other place, as may be decided by the arbitrator. The language of arbitration proceedings shall be English. The arbitrator shall make a reasoned award (the "Award"), which shall be final and binding on the parties. The cost of the arbitration shall be shared equally by the parties to the agreement. However, expenses incurred by each party in connection with the preparation, presentation shall be borne by the party itself.

Pending the submission of and/or decision on a dispute, difference or claim or until the arbitral award is published; the Parties shall continue to perform all of their obligations under this Agreement without prejudice to a final adjustment in accordance with such award.

# **Applicable Law and Jurisdiction**

The contract shall be governed by the laws of India for the time being in force. Subject to above (Resolution of disputes), the Courts of Delhi shall have exclusive jurisdiction in all matters or disputes arising under or in respect of this contract.

# Appendix-I INSTRUCTIONS FOR ONLINE BID SUBMISSION

As per the directives of Department of Expenditure, this e-auction document has been published on the Central Public Procurement Portal (URL: http://eprocure.gov.in). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

# pp. REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Click here to Enroll" on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
